



MEMBERSHIP PURCHASE AGREEMENT

This Membership Purchase Agreement (“Membership Agreement”) is entered into between the INDIAN HILL WINTER CLUB, INC., an Ohio non-profit corporation (the “Club”), and the applicant set forth on the signature page hereof (“Applicant”). This Membership Agreement offers you an opportunity to acquire an Equity Membership in the “INDIAN HILL WINTER CLUB,” a private equity membership club that will operate and offer access to winter sports and social activities within a facility located on land leased from the Village of Indian Hill in Camp Dennison, Ohio (the “Facility”). The Club and Applicant agree to the terms and conditions set forth herein.

Purpose of Club

The Club has been organized to develop, own, and thereafter operate the Club for the pleasure and recreation of its members, their immediate family members and guests. The Club will offer a wide range of recreational and social activities designed to bring friends, families and the community together during the winter months. Amenities include a regulation ice rink, a multi-purpose gymnasium, exercise and fitness rooms, a lodge-like great room, and platform tennis courts.

Initiation Fee

The initiation fee, redeemable membership bond, and annual dues associated with the various classes of Equity Membership in the Club are set forth in the attached Schedule A. The initiation fee for the class of membership selected must be paid to the Club by the Applicant upon execution and delivery of this Membership Agreement.

Redeemable Membership Bond Fee

Upon approval of the membership application, the redeemable membership bond shall be due and payable to the Club.

Upon a member’s withdrawing from the Club, the membership bond may be redeemed by the Club under certain conditions. The Club’s Code of Regulations describes the circumstances under which such bond may be redeemed by the Club.

Rely only on the Written Information Provided

No person is authorized to make any representations or to provide any information with regard to the Club or membership in the Club contrary to or in addition to the information contained in this Membership Agreement and the accompanying Code of Regulations. If any such representations are made or information provided, such representations should not be relied upon as having been authorized by the Club.

No federal, state, or other governmental authority has passed upon or endorsed the merits of the Club’s business, financing or membership plans. Every person who desires to purchase an Equity Membership in the Club should read all provided information carefully. v.

Membership Offered Only for Recreational Purposes; Risk of Loss

By executing this Membership Agreement, Applicant acknowledges that membership in the Club includes financial risk. If the Club cannot generate sufficient revenue to support debt service and operations, Applicant may suffer a total loss of membership amounts paid.

Equity Memberships are being offered exclusively for the purpose of permitting persons acquiring a membership to obtain recreational use of the Club facilities. Membership should not be viewed or acquired as an investment, and persons purchasing an Equity Membership should not expect to derive any economic profits from membership in the Club.

Agreement to Purchase an Equity Membership in the Indian Hill Winter Club

This is to certify that Applicant has received and carefully read this Membership Agreement and the attached Indian Hill Winter Club Code of Regulations. Applicant further agrees to the terms and conditions of membership as described and defined therein. With this Membership Agreement, Applicant hereby tenders the sum set forth on Schedule A hereto, which is the current required initiation fee associated with the class of Equity Membership in the Club selected by Applicant. This sum shall serve as a deposit, which shall constitute Applicant's Membership Application for the Indian Hill Winter Club. Upon receipt of the complete Membership Application, the Membership Committee of the Indian Hill Winter Club shall convene to consider the Application. Upon approval of the Application, the Applicant will be notified and the deposit immediately converted toward the initiation fee for Membership in the Club with such deposit being held pursuant to the terms of this Membership Agreement.

In the event that the Application is denied, the initiation fee shall be promptly refunded to the Applicant. The decision of the Membership Committee shall be final.

Risk of Injury

By signing below, Applicant acknowledges and recognizes that activities at the Indian Hill Winter Club, Inc. may involve risk of injury and agrees to accept any and all risks associated with them, including but not limited to property damage or loss, minor bodily injury, severe bodily injury, and death. Applicant hereby expressly agrees to indemnify, defend, and hold harmless The Indian Hill Winter Club, Inc., its officers, directors, employees, agents, volunteers and assigns for any claim arising out of or incident to the participation in Club activities by Applicant or members of Applicant's family, unless any such claim is caused by the willful misconduct of The Indian Hill Winter Club, Inc.
